Explanatory Notes and Conditions

Please read these notes and conditions carefully before completing an application for a license to engage in fishing and/or related activities. Further information and guidance are available from agents or directly from the office of the Nicaragua High Seas Fishing Unit.

Completion of the application form

 The application form should be completed by the beneficial owner or any legally appointed representative.

Section A: License Categories

2. You should specify here the type of license that you wish to apply for. A full list of license categories is contained in Annex A.

Section B: Vessel Details

3. Section B1 requires details of the specifications and identifiers particular to the vessel to be licensed. Most will be found in the vessel's Patent of Navigation issued by the Registry. These details will appear on the license; it is very important that you ensure that they are accurate. If any of these details change the license will become invalid and you must apply for a new license using an official application form.

Section B2 requires information on the details of the beneficial owner(s) and operators of the vessel. **International Business Corporation ownership is not accepted.**

Section B3 requires details of the person who you appoint to receive all licenses and notices including variations on your behalf or you may nominate yourself. Any notices issued and disseminated will take effect 24 hours after the nominee is informed. It is therefore very important that the nominee, or in his/her absence someone acting for him/her, is able to contact the vessel or its owner/operator at short notice.

Section B4 requires information on the vessel activities including RFMO area(s) where the vessel intends to operate, these include:

For vessels which target tuna, tuna-like species and sharks:

- ICCAT International Commission for the Conservation of Atlantic Tunas Atlantic Ocean
- IATTC Inter-American Tropical Tuna Commission Western Pacific Ocean
- IOTC Indian Ocean Tuna Commission Indian Ocean
- WCPFC Western and Central Pacific Fisheries Commission Eastern Pacific Ocean
- SPRFMO South Pacific Regional Fisheries Management Organization South Pacific

or vessels which will target non-tuna species

- Atlantic Ocean State coordinates of the area of operation or the EEZ State where the vessel will operate.
- Pacific Ocean State coordinates of the area of operation or the EEZ State where the vessel will operate.
- Indian Ocean State coordinates of the area of operation or the EEZ State where the vessel will operate.
- Other fisheries area State coordinates of the area of operation or the EEZ State where the vessel will operate.

For vessels which will engage in the carriage of marine resources, transshipment and bunkering services

 Ocean For vessels that will provide bunkering services, the type of service must be indicated.

Species that will be targeted under each category must be indicated in the space allocated.

Section B4 also requires information on the gear type, which will be indicated on the license. Any gear changes should be immediately notified and a new application should be requested to reflect the correct information. Type of refrigeration, method of processing or landing fish, carrying capacity and intended port of delivery are also required under this section.

Section B5 requires crew information on the vessel. Under this section, please provide the number and nationality of each deck and engine crew member.

Section C: Declaration

4. This declaration must be signed by all prospective license holders. In signing this declaration, you will be confirming that the details of the application are correct,

and that you understand the conditions that you will be expected to meet once

the license is issued. It is therefore particularly important to read the section headed "license conditions".

Documentation to accompany the application form

- 5. You should include with your application the following:
- 1. The vessel's current certificate of registry
- 2. For vessels which operate in the EEZ of another State, a valid license or permit is issued by that State.
- 3. Signed statutory declaration appointing a nominee or authorized representative
- 4. Ownership documents

Depending on the type of ownership the following documents will be required

a. Individual Owners

- The Name of the Bonafide physical permanent address of the owner
- ii. National identification card, passport or other similar
 identification in addition to documentation showing physical
 address

b. Corporate Owners

- 5. A copy of the certificate of incorporation and where applicable, a certificate of change of name
- 6. A certificate of good standing and a properly authorized mandate of the company to establish the business relationship.
- 7. A register of members or a list of the names and addresses of the shareholder holding controlling interest in the company
- 8. Copies of identification documents of at least two of the directors (if there is more than one) and authorized signatories of the company.
- 9. A copy of the memorandum and articles of association or bylaws of the company.
- 10. Document which authenticates bona-fide ownership and which clearly states permanent physical address of the company.

C. Partnership/Unincorporated business

- 11. In case of local limited partnerships:
 - o a copy of the certified registration
 - o certificate of good standing certified by the registrar of companies
- 12. In case of unincorporated business
 - evidence of the identity of a majority of the partners, owners or manager and authorized signatures

A copy of the mandate from the partnership or unincorporated business authorizing the establishment of the business relationship and confirmation of any authorized signatories.

Revocation of License

- Licenses are issued subject to the discretion of the Director of High Seas
 Fishing-NIATA and may be subject to variations, suspension and/or revocation at any time.
- 7. If a vessel is de-registered, its license will be automatically revoked.

License Validity in waters of another State

8. Any license issued is valid for operation on the high seas only. Vessels which operate in the EEZ of another State must hold valid authorization from that State. Based on the authenticity and validity verification by Nicaragua of the license or permit issued by another State, an accompanying authorization for operation in the EEZ of another State will be issued subsequent to the issuance of the HSFL.

License Validity in waters of another State

Licenses are subject to the following conditions, which must be met at all times and were specified therein.

- 9. The vessel must not engage in any unauthorized transshipment at sea or port without authorization.
- 10. The vessel must not retain on board, land or transship any fish in excess of the amount specified in their conditions for fishing.
- 11. The Vessel must be all time equipped with Vessel Monitoring system approved by NIATA.
- 12. The vessel shall target species only for which a license has been issued
- 13. The vessel must land and count against quota any fish which are subject to quota, which are retained on board and which are not returned to sea immediately.
- 14. The vessel shall not engage in activities with other vessels which do not appear on the list of authorized vessels of the area where vessels operate.
- 15. The vessel and its gear must be marked in accordance with relevant regulations
- 16. The following shall be carried on board the vessel to which they relate at all times and be available for inspection on the spot by any authorized officer:
- The license and any current variation issued by the Nicaragua Fisheries Unit-NIATA
- The vessel's certificate of Registry
- EEZ license/permits (if applicable)
- NIcaragua Authorization to Operate in the EEZ of another State (if applicable)
- Logbooks assigned to the vessel

Warning

If the Director has grounds to believe that the information contained in this application or any documents provided thereto is false or misleading, the application will be denied.
