Circular: Reg. use and acceptance of the electronic certificate issued by NIATA, Nicaragua

Subject: USE AND ACCEPTANCE OF ELECTRONIC CERTIFICATES BY ALL THE RELEVENT PERSONEEL AND AUTHORITIES

1. Reference

- 1.1 Marine Notice 101.1 Requirements on Carriage of Publications on Board Ships
- 1.2 IMO Circular FAL.5/Circ.39/Rev.2 Guidelines for the Use of Electronic Certificates

2. Purpose

- 2.1 The purpose of this Merchant Marine Circular is to inform that the **Nicaragua International Aquatica Transportation Administration** support and advocates the use of the Guidelines for the use of electronic certificates, adopted by the International Maritime Organization by the Facilitation Committee for the use of electronic certificates through the FAL.5/Circ.39/Rev.2 of 20 April 2016, in order to facilitate the use and acceptance of electronic certificates.
- 2.2 In this regard, ROs issuing statutory certificates to Nicaragua Flagged ships on behalf of the Nicaragua International Aquatica Transportation Administration are authorized and encouraged to develop capabilities to issue electronic version other statutory certificates, to replace the traditional paper statutory certificates.

3. Background

3.1 The International Maritime Organization (IMO) guidelines, as contained in IMO Circular FAL.5/Circ.39/Rev.2, set out the features for electronic certificates to enable stakeholders to verify their authenticity. The guidelines are intended to alleviate the problems inherent in paper documentation and facilitate the maritime sector's move toward the use and acceptance of electronic certificates

4. Information page1 of 2

- 4.1 The electronic certificates (Provisional) issued by Nicaragua International Aquatica Transportation Administration and statutory certificates issued by ROs to the registered ships shall comply with FAL.5/Circ.39/Rev.2 which, inter alia, identifies the following features:
 - i) validity and consistency with the format and content required by the relevant international convention or instrument;
 - ii) Protected from edits, modifications or revisions;
 - iii) a unique tracking number for verification;
 - iv) reliably and securely verifiable through a conveniently accessible and continuously available platform; and
 - v) a printable and visible symbol that confirms the source of issuance.
- 4.2 The electronic statutory certificates issued by ROs in accordance to FAL.5/Circ.39/Rev.2 shall be deemed valid in accordance with all applicable international instruments. In addition, the ROs must provide clear and simple instructions for any party who may wish to verify the validity and authenticity of the electronic statutory certificates.
- 4.3 Notwithstanding the compliance with requirements under the Nicaragua International Aquatica Transportation Administration, owners of Nicaragua Flag ships should still continue to exercise the necessary due diligence to address any entry and clearance requirements that are specific to foreign ports that the ship calls at.
- 4.4 Owners of Nicaragua Flag ships who wish to be provided with electronic certificates should approach the RO to enquire same and to confirm the suitability of Contact the ship to replace the traditional paper certificates with electronic versions.
